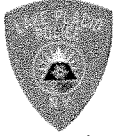

## Village of Lake Placid Annual Parking Permit Application valid May 10, 2024 to May 10, 2025

Parking Permits are available only to  
Main Street Residents and Main Street Employees

Proof of residency or employment must be included in your application.

A parking pass entitles the permit holder to a parking space on an *as-available* basis in designated locations within the Village.  
**This permit DOES NOT guarantee you a parking spot!**

The annual parking permits are valid for 1 year  
May 10, 2024, to May 10, 2025

All Village ordinances concerning parking are strictly enforced.  
It is your responsibility to follow all posted signs and regulations.

No overnight parking on Main Street

No overnight parking as posted in parking lots

This permit can only be used in designated parking area/spaces This permit cannot be used for metered spaces.

Misuse of this permit may result in revocation of the permit

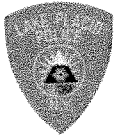
Permit must be displayed from rear view mirror with permit facing forward when vehicle is parked in legal permitted parking locations

\$1,025.00 Annual fee for transferable Business/STR for each permit up to 5 permits

\$1,275.00 Annual fee for transferable Business/STR each for permits 6 to 10  
There is a 10 permit limit

\$ 200.00 Annual fee for non-transferable Resident/Employee permit

### Pro-rated parking Permits

- \$200.00 (May 10, 2024 – May 10, 2025) 12 months
- \$150.00 (purchased in September 2024 – May 2025) 9 Months
- \$100.00 (purchased in November 2024 – May 2025) 7 Months
- \$ 50.00 (purchased in March 2025 – May 2025) 3 months

### Designated Annual Permit Parking Areas

- The Corral (Upper Lot) located across from the NBT Bank
- Right and Left Side of the Corral of the upper NBT Lot
- Hayes Street located next to St. Eustace Episcopal Church (one-way street)
- Saranac Avenue across from Bluebird Hotel & Suites
- Elm Street Located behind the High Peaks Resort
- West Side of Mirror Lake Drive from Brewster Park to Swiss Road
- East Side of Mirror Lake Drive from Brewster Park to Swiss Road (not including designated loading zone)
- Stewarts Parking lot in designated spaces along the back wall
- Beach House parking lot in designated spaces (this location is replacing spots directly on Parkside near the Adirondack Community Church)
- Main Municipal Lot (if you are unable to find permitted parking spaces elsewhere, at no additional cost)

### Guidelines for Annual Permit Parking

- Application must be readable and completed in its' entirety
- All outstanding parking violations must be paid in full

- This permit can only be used in the designated parking areas/spaces
- This permit may not be used to park at metered spaces
- If an annual permit holder is unable to find a spaces in any permitted parking area, they can park anywhere in the main Municipal Parking lot at no charge
- Permit holders must abide by all Village ordinance regarding parking
- This annual permit does not guarantee the holder a parking space
- Misuse of this annual permit may result in revocation for the year
- Replacement permit is \$15.00

### **Accessible Parking**

Annual permit holders that have been issued handicapped parking permits may park in any handicapped parking spot in the NBT Lot, Clock Lot, Municipal Lot, and Stewarts lot.

Handicapped spots located directly on the main street will not be available to these permit holders without a metered parking waiver. This waiver must be visibly displayed while parked. The application for the metered parking waiver can be found at <https://dmv.ny.gov/forms/mv6642mp.pdf> . Please print this waiver and attach it to your parking permit application.

**The Lake Placid Annual Parking Permit must be visibly displayed.  
Please hang this permit on your rear-view mirror facing out towards the street.**

### Annual Transferable STR/Business Parking Permit Application

valid May 10, 2024 to May 10, 2025

This application is for a transferable parking permit purchased for businesses and/or short term rental properties. This is in accordance with Local Law No. 1 of 2020; section 11.4 (A), of the Village of Lake Placid/Town of North Elba Land Use Code which regulates short-term rentals in the Village of Lake Placid.

This permit is for rental properties located from One Main Street (Brewster Park) to the US Post Office ONLY! This permit is not for personal use by the STR/business owner. Misuse of this annual permit may result in revocation for the remainder of the permit year.

**6-10 Transferable Permits \$1,275.00 each**

**Maximum of 10 transferable permits will be issued per business**

The application for the annual parking permit is limited to 1 vehicle per permit; you must purchase an annual permit for each vehicle. If you have any outstanding parking violations with the Lake Placid Village Court your application will be denied until all tickets are paid in full. Any annual permit already issued that needs to be replaced (new car, summer car, winter car, etc.) will cost \$15.00. Misuse of this annual permit may result in revocation for the year.

*It is your responsibility to follow -up on the status of your application. The cost is \$200 per vehicle and is not transferable. Accepted forms of payment are cash or check made payable to the Village of Lake Placid.*
