DWI Warning

1. You are under arrest for driving while intoxicated.
2. A refusal to submit to a chemical test, or any portion thereof, will result in the immediate suspension and subsequent revocation of your license or operating privilege, whether or not you are found guilty of the charge for which you are arrested.
3. Your refusal to submit to a chemical test, or any portion thereof, can be introduced into evidence against you at any trial, proceeding or hearing resulting from this arrest.
4. Will you submit to a chemical test to determine the alcohol or drug content of your blood?

Miranda Warning

1. You have the right to remain silent and refuse to answer any questions.
2. Anything you do say can and will be used against you in a court of law.
3. As we discuss this matter you have a right to stop answering my questions at any time that you desire.
4. You have a right to a lawyer before speaking to me, to remain silent until you can talk to a lawyer, and to have that lawyer present with you when you are being questioned.
5. If you do desire a lawyer, but you cannot afford one, one will be provided to you before questioning without cost to you.
6. Do you understand each of these rights I have explained to you?
7. Now that I have advised you of your rights, are you willing to answer my questions?

DWAI / DRUGS Warning

1. You are under arrest for driving while ability impaired by the use of drugs.
2. A refusal to submit to a chemical test, or any portion thereof, will result in the immediate suspension and subsequent revocation of your license or operating privilege, whether or not you are found guilty of the charge for which you are arrested.
3. Your refusal to submit to a chemical test, or any portion thereof, can be introduced into evidence against you at any trial, proceeding or hearing resulting from this arrest.
