Village of Lake Placid Annual Parking Permit Application for Short-Term Rentals 2021 – 2022

This annual parking permit does not guarantee you a spot.

The annual parking permits are valid for 1 year, beginning May 10, 2021. The rules are as follows:

**You must abide by all Village Ordinances concerning the parking laws.
This permit does not allow you to park overnight on Main St or in the lots on the posted designated night**

This permit can only be used in the designated parking areas/spaces as outlined on the attached sheet

This permit cannot be used for metered spaces or areas

The yearly price for Resident/Business permit is \$150.00.
The yearly price for Short Term Rental is \$1,000.00

NOTE : There will be a \$10.00 replacement fee for any issued permit.

Misuse of this permit may result in revocation for the year.

THIS PERMIT EXPIRES MAY 10, 2022

It is your responsibility to follow-up on the status of your application.

Guide Lines for Annual Permit Parking – Short-Term Rentals

- Application must be readable and completed in its entirety
- This permit can only be used in the designated permit parking areas/spaces
- This permit may not be used to park at metered spaces
- If a Permit Holder is unable to find a space in any permitted parking areas, they can park in the main Municipal Parking Lot at no charge
- Permit Holders must abide by all Village Ordinances regarding parking regulations
- Replacement permit is \$10.00
- This annual permit does not guarantee the holder a parking space
- This permit is for use by the renter ONLY not the homeowner
- Misuse of the permit will result in the revocation for the remainder of the permit year.

Designated Annual Permit Parking Areas

- The Corral (Upper lot) located across from NBT bank
- Right and Left Side of the Corral of Upper NBT Lot
- Hayes Street located next to Episcopal Church (one way street)
- Saranac Avenue across from Summit Hotel Resort & Suites
- Elm Street located behind High Peaks Resort
- West Side of Mirror Lake Drive from #1 Main Street to Swiss Road
- Main Municipal Lot (if unable to find permitted parking space elsewhere, at no additional cost)
- East Side of Mirror Lake Drive #1 Main Street to Swiss Road
- Parkside Drive near Adirondack Community Church
- Stewarts Parking Lot in designated spaces along the back wall

This application is for the annual parking permit you must purchase for your short-term rental property. This is in accordance with Local Law No. 1 of the year 2020, Section 11.4(A), of the Village of Lake Placid/Town of North Elba Land Use Code to regulate short-term rentals in the Village of Lake Placid.

This permit is for rental property from the US Post Office to One Main Street ONLY and not for personal use by the business owner. Misuse of this annual permit may result in revocation for the remainder of the permit year. **It is your responsibility to follow-up on the status of your application. The cost is \$1,000.00 which is transferrable for the permit year only.**
